1. Must be a member of Lambda chapter.
2. Must have attended not less than 75% of chapter meetings since initiated into Theta Tau.
3. All dues and other fees must be paid up.
4. Must have been initiated into Theta Tau before end of Junior year.
5. Must have highest scholastic standing on all college work to the end of the first quarter of the Senior Year.
6. Actual award at the discession of the I.A.A. of Theta Tau Executive Committee and Advisory Board.
7. Must be enrolled as a student at the time of the award and must be a candidate for graduation at the end of the Spring Quarter.

These requirements were adopted at a meeting of the Executive Committee and the Advisory Board held January 11, 1942. Wm. Cope and George Carter represented the Faculty at the meeting.

At an Executive Committee and Advisory Board meeting held Jan. 20, 1943 the 7th requirement was changed to include all those who have graduated since April 27, 1942 up to and including those who will graduate March 17, 1943.

CARL A. BERGMAN was the winner of the first \$50.00 scholarship which was awarded at the March 7, 1942 Banquet.
